

2026 FPC Advocacy Academy Syllabus

In 2026, customized advanced FPC trainings are designed to strengthen FPCs' ability to effectively engage Congress. NAR Advocacy will focus the 2026 FPC training of the FPC Advocacy Academy on three groups:

1. New FPCs who have completed the FPC Advocacy Academy and are entering their second year of service;
2. Veteran FPCs; and
3. New FPCs who did not receive the full FPC Advocacy Academy training in 2025.

Additionally, 2026 will mark the launch of NAR Lobbyist Office Hours and quarterly FPC Mentorship Zoom sessions, optional for any FPC looking for some peer feedback or additional support.

January 2026 (Webinar)

Symposium #1 | 2026 Legislative Outlook, a Citizen Advocate's Toolkit & Launch of NAR Lobbyist Office Hours

- Audience: ALL FPCs
- Timing: January 2026
- Program Content: As Vice President of NAR Advocacy, Joe Harris will welcome FPCs back for 2026 and provide a broad legislative outlook on our policy priorities in the coming year, while also highlighting our successes from 2025. Victoria Givens, Manager of REALTOR® Mobilization Programs, will review key lessons learned from the FPC Advocacy Academy, including more than a dozen strategies for connecting with elected officials both online and offline. She will also guide FPCs through the major tools they should be using to achieve their grassroots goals, including RPR reports, NAR research, and the FPC Resources page.

The presentation will cover social media engagement, town hall meetings, telephone town halls, in-district meetings, and letters to the editor. Finally, FPCs will be reintroduced to their Lobbyist contacts and participate in their first Lobbyists Office Hours session.

Symposium #2 | The Nuts and Bolts of Being a New FPC & Knowing Your FPC Advisory Committee Leaders

- Audience: New FPCs
- Timing: January 2026
- Program Content: Victoria Givens, Manager of REALTOR® Mobilization Programs, will be joined by her colleagues from Aristotle and 1Huddle to introduce both platforms to the group. They will guide new FPCs through filing field reports, participating in regular 1Huddle interactive training games, and building an FPC team.

The Chair, Vice Chair, and Immediate Past Chair will then lead FPCs through the role of the Committee in supporting FPCs as they carry out their responsibilities.

Finally, FPCs will break out into Office Hours with their Political Representatives.

- Program Content: April is Fair Housing Month, and NAR's Alexia Smokler, Director of Fair Housing Policy and Programs and Erin Stackley, Director of Commercial and Policy Oversight will take FPCs inside NAR's 360-degree approach to fair housing. They will also explain how NAR establishes its general legislative policy and the structure that supports it, including NAR leadership, the NAR liaisons, and the Public Policy Coordinating Committee (PPCC). Finally, they will provide an overview of Robert's Rules of Order.

Jessica Lautz, Deputy Chief Economist and Vice President of Research will present on NAR Economic Area Reports and other key research resources, highlighting work that will be particularly useful as FPCs prepare for their meetings on Capitol Hill.

Lobbyist Office Hours & Know Before You Go Prep for REALTOR® Legislative Meetings

- Program Content: Interacting with policymakers back home is one of the most effective ways to secure meaningful "quality time" with key decision makers. By giving policymakers the opportunity to personally see, feel, and experience the places where their constituents convene, live, work, and gather, site visits help them better understand community perspectives and often spark ideas for new legislation.

In this session, the NAR Advocacy Team will review the August recess talking points and outline expectations for the FPC in-district meetings. Participants will learn the most effective in-district advocacy strategies for building lasting relationships with policymakers and their staff. The program will walk through the steps for planning, scheduling, and conducting impactful in-person and virtual visits that leave a strong and lasting impression on Members of Congress.

Power Shifts and Freshmen: What to Expect with a New Congress

When power shifts in Congress from one political party to another, an FPC who previously represented an anonymous backbencher may suddenly become the conduit to one of the most influential lawmakers for our issues.

In this presentation, the NAR Lobbyists will show advocates how to build relationships with new Members of Congress and highlight the importance of identifying key committee chairs, explaining why some roles carry more influence than others. Victoria Givens, Manager of REALTOR® Mobilization Programs, will then walk through best practices for building relationships with new policymakers back home.
